7. Booth location is given upon vendor check in during show setup. Location requests are honored as received but not guaranteed.
8. Any additional tables, displays, etc., are the responsibility of the vendor & must fit in your designated space and clear all aisles and walkways.
9. Event coordinator has final say in all space disputes.
10. HNM Cat Rescue and the Jefferson County Fair Board assume no risk, by signing this Agreement, the Vendor expressly releases HNM Cat Rescue and the Jefferson County Fair Board from any and all liability for any damage, injury, or loss to any person or goods which may arise from the rental and occupation of said space by the Vendor, and agree to hold and save HNM Cat Rescue and Jefferson County Fair Board harmless of any loss or damage by reason thereof.
